THE MEETING WAS CALLED TO ORDER AT 9:30 P.M. BY CHAIRPERSON **PINSKE**

WORK WITH CITY FORESTER ON TYPE TO BE PLANTED AND WHEN TO PLANT

1. A TOTAL OF (5) TREES TO BE PLANTED (2) OF THE SAME SPECIES TO BE PLANTED AT THE CEMETARY ENTRANCE. (3) TO BE PLANTED ALONG THE SOUTH SIDE THAT IS NOW BEING OPENED FOR PLOT SALES. SELECTED SITES : **SECTION 3 - LOTS 5 & 6, SECTION 10 - LOTS 5 & 6, AND SECTION 17 - LOTS 13 & 14.**

2. THIS TREE PURCHASE AND PLANTING COULD BE DONE IN CONJUNCTION WITH THE CITY'S TREE PLANTING PROGRAM.
