2014 PET LICENSES ARE HERE!

All pet licenses issued in 2013 will expire on March 31. According to City Ordinance 283, all domesticated pets (dogs and cats) must be licensed. Residents are encouraged to stop by the City Office before April 1 to obtain a 2014 pet license. The cost for the license before April 1 is \$5 per pet. Residents must also provide a health certificate showing that the pet is current on its rabies vaccination. Due to the spring vaccination schedule, your pet may not be due for vaccinations until after April 1. You should still license your pet in March to avoid late fees. You will be permitted to bring the health certificate in at a later date. Licensing your pet assures that it will be taken care of and returned safely if it gets loose and is picked up by the Police Department. Residents should also be aware that a total of only 3 adult (includes spayed or neutered) pets are allowed per household. Also, if you have lost (ran away, gave away or died) pets within the last year, please notify the City Office so we can remove the pet from our current listing. The City will be following up on our listing of pets again this year. Residents should also remember that pets are not permitted to run at large within City limits. Pets must either be leashed or cabled/chained, kenneled or in a fenced yard and are not allowed to roam freely.

HELP WITH SNOW MELT

With the record setting snow fall of this past winter season, the City of Arlington is asking residents to help prevent street flooding and icing by clearing snow away from storm sewer catch basins. When the weather turns warmer and snow begins to melt, it's important that the runoff water is able to get into the storm sewer. If the catch basin is covered by a build-up of snow and ice, street and yard flooding can occur. Thank you.

CITY BOARD OF APPEAL & EQUALIZATION HEARING SET FOR APRIL 22

The annual Board of Appeal and Equalization for the City of Arlington will meet, by appointment, at the Office of the Sibley County Assessor, from 3:00 p.m. to 8:00 p.m. on Tuesday, April 22. The purpose of the meeting is to determine whether taxable property within the City of Arlington has been properly valued and classified by the Assessor, and to determine whether or not corrections are needed to be made for the year 2015. If you believe the value or classification of your property is incorrect, or if you wish to express your concern that the property of another is valued too low, please contact the County Assessor's Office to discuss your concerns. If you are still not satisfied with the valuation or classification after discussing it with your Assessor, you may appear before the City Board of Appeal and Equalization. The Board will review the valuation, classification or both if necessary under an open-book style of meeting, and shall correct it as needed. Generally, an appearance before the Board of Appeal and Equalization is required by law before an appeal can be taken to the County Board of Appeal and Equalization.

UPCOMING CURBSIDE GARBAGE COLLECTION

Notice to Arlington residents and business owners. Due to the time of year that should be coming soon, the gravel alleys will be getting soft and cannot handle the large garbage trucks driving on them. Due to this condition, which the City anticipates sometime in March, we will be asking all residents and businesses to place their garbage cans and recycling containers curbside. Garbage companies will also be notified and will be asked not to drive through the gravel alleys until such a time that the alleys have dried out. Please keep watching the Arlington Enterprise for a notice of when this change in garbage hauling will actually take place, depending on weather conditions. Areas with cement alleyways are excluded from this notice.

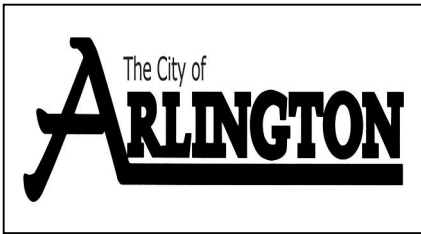


MOWING HELP WANTED

The City of Arlington is accepting applications for the following seasonal positions:

Mowing/Weed Trimming Positions -- The season will start *tentatively* May 1st and run approximately 24 weeks, subject to the growing season (dryness, wetness, early/late frost). The hours for lawn mowing/trimming are Monday-Friday 8am-6pm. Areas mowed/trimmed include the parks, public cemetery, and around City buildings. No weekend or evening mowing/trimming will be permitted. Approximately 32 hours per week will be spent mowing/trimming and maintaining equipment (oil changes, clean out decks, etc.). Seasonal part-time wage is \$8.75 per hour. Applicants must be 18 years or older to apply and have a valid driver's license. The City is preferably looking for individuals to mow/trim for the entire season. Applications will be accepted for backup mowers to help with the first half (April-May) and second half (August-October) of the season, as needed.

MARCH ENERGY SAVING TIPS

**When washing clothes, switching your temperature setting from hot to warm can cut energy use in half, while using the cold cycle reduces energy use even more. Save energy by washing full loads of laundry in cold water. A half load uses almost as much energy as a full, and water heating consumes about 90% of the energy it takes to operate a clothes washer.

** Reduce your water heating costs by lowering the thermostat on your water heater. For each 10°F reduction in water temperature, you can save three to five percent in energy costs.
