NOTICE TO CITY CREDIT/ DEBIT CARD USERS

As of Tuesday, October 25th, the City's change in credit/debit card processing vendor finally took effect. 'RevTrak' will no longer be used, and 'Point & Pay' is the City's new processing vendor.

As publicized at the beginning of 2016, with this vendor change comes the implementation of a convenience fee for all credit/debit card transactions. Due to contract specifics and setup functionality being finalized, this process took longer than anticipated.

Beginning Oct. 25, 2016 – whether paying on-line, by phone, or in person – a 2.5% convenience fee (\$2 minimum) will apply to all card transactions.

E-check payment option (customer initiated electronic withdrawal from a checking account) will also be available for a flat \$1.50 fee.

Returning on-line Webstore users will notice a new look and should be aware that their existing account/profile information will be lost, as customer information is unable to be transferred to the new vendor. The City will still be accepting cash or checks by mail/in-person/payment box with no additional costs.

TRUTH-IN-TAXATION HEARING

Ever wonder exactly what your tax dollars pay for? Want to know what the City spends its money on? Is there wasted spending? To answer these questions, and many others, the City Council will be conducting its annual Truth-in-Taxation Hearing on Monday, December 5th at 6:00 p.m. in the Council Chambers at the Community Center. City Staff will review next year's proposed revenues and expenses. It is the Council's goal to bring down the proposed levy by the final levy date in December. City Staff will explain the reason behind any proposed increase and will touch on how the 2017 budget will affect the City and its property owners. SENIOR BUILDING CONSTRUCTION AND DAMAGE/ CLEANING DEPOSIT CHANGES

 City Staff was notified in late summer that the Arlington Lion's grant application, to remodel the Senior Citizen's Building at Four Seasons Park, was approved. Due to contractor availability, construction will start after the warming house closes for the season in late winter 2017. They anticipate construction to last 2-3 months, and per the grant, all construction work must be completed by July 2017. Unfortunately, during construction, the Senior Building will not be available for rental. If residents were intending on using the Senior Building during that time frame, we are asking that you please plan for another location. At this time, City Staff is unsure of the exact start and end dates, but has started a waiting list for late spring/early summer rentals.

Unfortunately over the summer, there has been several events at the Senior Building where the building's cleaning policies and rules were not followed. As a direct result of this, at the October 17th City Council meeting, the City Council opted to raise the damage/cleaning deposit for the building from \$25.00 to \$250.00, effective immediately to new rentals. This new amount is solely a damage/cleaning deposit. As long as the facility is returned to a clean and neat manor, when inspected by City Staff following every event, this amount will be fully refunded. SNOW EMERGENCY NOTICE—VEHICLES & TRAILERS

Although we probably don't want to admit it, the Minnesota snow season is right around the corner. Residents and business owners should remember that the City of Arlington will be plowing and hauling snow anytime there is a snowfall of two (2) inches or more. The City asks that all residents park all vehicles and trailers off the streets and avenues until they are plowed from curb to curb or they will be ticketed and towed. Vehicles that interfere with City maintenance activity, such as snow removal may be towed to a designated area at the expense of the owner. The vehicle may be impounded until all parking fines, towing and storage charges have been paid. Unclaimed vehicle will be sold and the proceeds applied first against such fines and charges. Repeat violators will be towed without additional notice.

SNOW EMERGENCY NOTICE—SIDEWALKS

Property owners should also remember that city ordinances require that all ice and snow must be removed from all public sidewalks within 12 hours after such snow and ice has ceased to be deposited upon such sidewalks. Failure to remove the snow or ice within 24 hours may be a cause for the City to do so itself. If the City, or an agent assigned by the City, has to remove the snow, the City will bill the property owner accordingly. Unpaid bills for snow removal will be a cause for a special assessment against the property.

OTHER REMINDERS ON SNOW REMOVAL

The City would also like to remind residents that it is illegal to remove snow/ice from private property and deposit it upon a public street in such a manner as to cause a hazard to travel, without proper arrangements for the immediate removal thereof. Also, no garbage dumpsters shall be places in the public right-of-way during the winter snow season (November 1– April 1).
