JULY 31–AUGUST 4





WOULD A BACKFLOW PREVENTER HELP?

The City empathizes with residents who experienced storm water or even sewage in their homes due to the heavy rain storm in early July.

Unfortunately, when torrential rains occur, many circumstances are beyond the City's control. While the City continues to do everything it can to prevent this from recurring, we want to make you aware of some options that are available to individual property owners. These can include the installation of a backflow preventer or slicer valve into your sanitary sewer line. Both kinds of valves would require



installation by a plumber, and can typically be done for less than \$500, depending on how your lines are situated. A backflow preventer valve would automatically shut down upon detection of flow coming back up through the line (as illustrated). A slicer valve requires your presence during an emergency, to manually close a steel panel in the valve. In the past there has been some confusion on the types of meetings a City Council can hold. The Arlington City Council, and its committees and boards, are governed by the Minnesota Open Meeting Law. One might also hear the word quorum, which means the minimum number of members of an assembly or society that must be present at any of its meetings to make the proceedings of that meeting valid. The Open Meeting Law serves three purposes:

- 1) The law prohibits actions being taken at a secret meeting where it is impossible for the interested public to become fully informed about a public board's decision or to detect improper influences.
- 2) It assures the public's right to be informed.
- 3) The law affords the public an opportunity to present its views to the public body.

In general, there are three types of meetings that a City Council conducts: open meetings, closed meetings, and public hearings.

Open Meetings— Most meetings of the Arlington City Council are open to the public. There are two different types of open meetings, regular and special. The Arlington City Council conducts two regular open meetings a month; the 1st and 3rd Mondays at 6:30 pm. These regular meetings are used to discuss, decide or receive information on matters over which the council has authority. Simply, the day to day policy decisions of the City are decided at the semi-monthly regular meetings.

Special meetings are meetings held at times or places that are different from the regular scheduled meetings. These are often scheduled to deal with specific items that need to be addressed before the next regular meeting. Any person may observe a regular or special meeting of the Council. However, while anyone can attend an open meeting, they are not guaranteed the opportunity to speak or otherwise participate in any discussion at the meeting. Generally, open meetings provide the opportunity for the public to witness the actions of the City Council. On certain occasions, the Mayor or City Council can recognize someone from the public to comment on a specific action item. The City Council does provide at their regular meetings, a "Citizens Addressing the Council" portion of the agenda for residents to comment on non-agenda items. Citizens looking for a specific action from the Council should ask to be placed on the agenda prior to the meeting. Please contact the City Office several days in advance to request time on the next agenda.

Closed Meetings— Under certain circumstances, some meetings (or a portion of a meeting) of the City Council may or must be closed to the public. Meetings that *may* be closed revolve around labor negotiations, performance evaluations, and attorney-client privileges. Meetings that *must* be closed are meetings that deal with discussion on data that is considered private under state law, and for preliminary consideration of allegations or charges against an individual subject to the public body's authority. In the case that the City is dealing with an allegation or charge against an individual; the individual in question may ask, and the City must grant, that the closed meeting be made open to the public for *viewing* purposes.

Public Hearings— A public hearing is a meeting that is held where members of the public get to express their opinions on a particular item. The Council is there to regulate the hearing and make sure that people who want to speak on the issue get the opportunity. The council does not deliberate or discuss matters at the public hearing, but instead listen in order to formulate an opinion on the matter at hand. Certain issues like special assessments and zoning/ordinance amendments require, by law, a public hearing. From time to time, the City Council will hold a public hearing even if they are not required to do so by law, for the purpose of allowing the public to comment on a specific issue.

AUGUST 1st NEW LAWS TAKING EFFECT



HANDS FREE-Minnesota will join a growing list of states with prohibitions on holding cellphones and other wireless communication devices while behind the wheel. The new law broadens the state's existing ban on texting while driving, barring drivers from holding a cellphone or other wireless communication device while operating a motor vehicle that is in motion on a street or highway. Drivers will be required to use hands-free technology when making calls, sending messages, or accessing content (including audio and navigation software) behind the wheel.

SLOWPOLK LANE- Part of this new transportation law clarifies requirements on operating slow vehicles on the right side of the road and moving out of the left-most lane to allow others to pass. If a roadway has more than one lane in each direction, a slower driving person must now move out of the left-most lane to allow another vehicle to pass, when practicable.

MARITAL RAPE- The effect of this new law is to remove the so-called "marital rape exception" or "voluntary relationship defense" and permit the prosecution of individuals accused of committing sexual crimes against a spouse or a long-time partner. The law will repeal language that a person does not commit criminal sexual conduct if the conduct is between "adults cohabiting in an ongoing voluntary sexual relationship at the time of the alleged offense, or if the complainant is the legal spouse, unless the couple is living apart and one of them has filed for legal separation or dissolution of the marriage." This change took effect July 1, 2019.
